CCSNH Pell Recalculation Policy

The Pell Recalculation Date (PRD), also known as the **Financial Aid Freeze Date**, is the date when the Financial Aid Office locks your enrollment for the semester. On this date, the Financial Aid Office calculates the number of credits you are enrolled in to determine your eligibility for the Pell Grant or other federal grants.

For the Summer 2025 Semester (202530):	<u>Freeze Date is Tuesday, June 17, 2025</u>
For the Fall 2025 Semester (202610):	<u>Freeze Date is Tuesday, September 16, 2025</u>
For the Spring 2026 Semester (202620):	<u>Freeze Date is Tuesday, February 10, 2025</u>

- You should register for ALL courses you plan to attend for each semester at any CCSNH college on or before the **Freeze Date**
- Classes added or dropped after the **Freeze Date** will not affect your Pell Grant award (increase or decrease) for the semester.
- If you withdraw from a course(s) **prior to the Freeze Date** the credits for the course(s) will not be Pell eligible.
- If you do not attend classes for which you received the Pell Grant, you will be subject to a Pell recalculation.
- If you withdraw from all courses officially or unofficially, you may be subject to a "Return of Title IV" calculation, and a reduction of federal financial aid dollars.

The full Fall 2025 202610 semester for all colleges begins on Monday, August 25, 2025

The full Spring 2026 202620 semester for all colleges begins on Tuesday, January 20, 2026

CCSNH colleges have multiple start dates within each semester. Check your schedule carefully so you know when your classes begin.

If you have not registered at the college before each semester's **Freeze Date** and you then register for courses that begin later in the semester, you should register for those courses at the same time to maximize your eligibility for the Pell grant or other federal grants.

To be eligible for federal loans, you must be registered for at least six (6) credits at the time of disbursement.
